Migrants' Human Rights: The Advocates mobilized 845 pro bono legal professionals to provide free immigration legal services to people fleeing persecution or torture, unaccompanied children, trafficking survivors, and people in detention in FY25. In FY25, we delivered legal assistance in approximately 3,000 cases to people living throughout the Upper Midwest.

International Justice: The Advocates promotes international human rights by partnering with human rights defenders, coalitions, and affected communities to abolish the death penalty and protect the rights of LGBTQ+ people, women, migrants, and others facing violence and discrimination. Engaging more than 350 volunteers, The Advocates documents violations, amplifies the voices of human rights defenders, and leverages international human rights mechanisms to influence local change. In FY25, The Advocates collaborated with 54 human rights partners in 51 countries to strengthen protections and drive legal reform.

Research, Education, & Advocacy: The Advocates engages volunteers through the Immigration Court Observation Project to monitor hearings, expose systemic rights violations, and press for reform, with more than 1,400 participants since 2017. The Advocates also advances policy change to align U.S. federal, state, and local laws with international human rights standards. The Advocates combats sex and labor trafficking by addressing the root causes of trafficking, prioritizing survivor protection and agency, and reforming law, policies, and systems.

The school provides an entirely free education, including textbooks, uniforms, and a daily meal, to 375 students enrolled in pre-K through grade 10. More than fifty percent of students are girls.

In Minnesota, The Advocates' WATCH project uses court observation to ensure the court system, and the justice system more broadly, provide access to justice for victims of violence while protecting the human rights of those in the justice system, including victims.
