## **MAKING REFERRALS**

You will find individuals with possibilities for relief for removal. If the individual is not able to afford an attorney, they may be eligible for legal assistance from one of the three service providers. If you believe the person is eligible, please retain a copy of the NTA & I-213 and the intake form and forward those along by fax or mail to the agency to whom you are referring the case. Please do this promptly, so the agency has sufficient time to follow up before the next hearing. A two-week continuance should be requested to provide enough time for the agency to consider the case and contact the individual. The following are guidelines for referral:

- 1. Which cases to which agency?
  - a. The Immigrant Law Center of Minnesota: any good case, regardless of residence

  - b. The Advocates for Human Rights: asylum only no criminal convictions, certain Withholding or CAT claims, but none with serious criminal convictions.

- 2. What is a "good case:"
  - a. LPR Cancellation
  - b. Withholding or CAT claim with equities
    - i. family members
    - ii. lower level offenses
    - iii. strong persecution fear
  - c. Refugee adjustment
    - i. Equities
    - ii. Family members
    - iii. Fewer crimes
  - d. Asylum
    - i. Fear "on account of" a protected ground;
  - e. Non-LPR Cancellation
    - i. Must have very strong equities for most agencies to consider.
  - f. U visa for crime victims
- 3. What to do to make the referral?
  - a. Call the agency you are referring the case to, and fax general information over the same day as Court.
  - b. Try to get a two week continuance.
  - c. Make sure you know the jail where the person is detained.
  - d. Never promise the person representation; tell them if the agency is able to help them, they will be contacted.
  - e. Best practice is for the referring agency to send a letter to the person if they will not be able to accept the case however this may not always happen.
- 4. If the person does not appear to qualify for free legal services, or the case does not fit within the "good case" guidelines, provide the private attorney referral list.
